Subject: Decision on appeal against non-accreditation of UG Mechanical Engineering program offered by Rajkiya Engineering College Azamgarh, Village-Aikbalpur, Post-Deogaon, Azamgarh – 276 201, Uttar Pradesh.

Sir,

This has reference to Appeal dated 02-03-2020 filed by **Rajkiya Engineering College Azamgarh, Village-Aikbalpur, Post-Deogaon, Azamgarh – 276 201, Uttar Pradesh** against the decision of NBA not granting accreditation to UG Mechanical Engineering program of your Institution, communicated vide NBA's letter of even number dated 05-02-2020.

2. The Appeal was considered by the Appellate Committee of NBA in its meeting held on 23-08-2021. The Appellate Committee recommended for holding re-visit to **Rajkiya Engineering College Azamgarh, Village-Aikbalpur, Post-Deogaon, Azamgarh – 276 201, Uttar Pradesh** for re-evaluation of UG Mechanical Engineering program. An Expert Team conducted onsite evaluation of the program from 20th to 22nd May, 2022. The report submitted by the Expert Team was considered by the concerned Committees constituted for the purpose in NBA. The Competent Authority in NBA has approved the following accreditation status to the program as given in the table below:

3. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.

4. The accreditation status awarded to the program as indicated in the above table does not imply that the accreditation has been granted to **Rajkiya Engineering College Azamgarh, Village-Aikbalpur, Post-Deogaon, Azamgarh – 276 201, Uttar Pradesh** as a whole. As such the Institution should nowhere along with its name **including on its letter head etc. write that it is accredited by NBA because it is program accreditation and not Institution accreditation. If such an instance comes to NBA's notice, this will be viewed seriously.** Complete name of the program(s) accredited, level of program(s) and the period of validity of accreditation, as well as the Academic Year from which the accreditation is effective should be mentioned unambiguously whenever and wherever it is required to indicate the status of accreditation by NBA.

5. The accreditation status of the above program is subject to change on periodic review, if needed by the NBA. It is desired that the relevant information in respect of accredited program as indicated in the table in paragraph 2, appears on the website and information bulletin of the Institute.
6. The accreditation status awarded to the program as indicated in table in paragraph 2 above is subject to maintenance of the current standards during the period of accreditation. If there are any changes in the status (major changes of faculty strength, organizational structure etc.), the same are required to be communicated to the NBA, with an appropriate explanatory note.
7. A copy each of the Report of Chairman of the Visiting Team and Evaluators' Report in respect of the above program is enclosed.
8. If the Institute is not satisfied with the decision of NBA, it may appeal within thirty days of receipt of this communication giving reasons for the same and by paying the requisite fee.
