(B) 2. Important Instructions: -

- University Examination fee of Rs 8,200/- (May vary according to AKTU guidelines) per semester has to be submitted by all the students directly through AKTU ERP Portal.
- All the newly admitted students through UPTAC-2022 are required to deduct seat acceptance fee (submitted at the time of counselling) of Rs. 20,000/- (for Gen/OBC students) or Rs. 12,000/- (for SC/ST students) from the Total Fees given in Tables I, and II (whichever is applicable).

[For example, if the fees of a newly admitted student is Rs. 63,100/- and he/she has deposited Rs. 20,000/- at the time of counselling, then he/she has to pay an amount of Rs. 43,100/- (i.e. Rs. 63,100/- - Rs. 20,000/-) only].

(B) 3. (i) Fee Submission Mode: -
